### **SUBCHAPTER 9. LIVESTOCK DEALERS AND LIVESTOCK SPECIAL SALES**

#### **PART 3. LIVESTOCK SPECIAL SALES**

##### **35:15-9-7 Application**

Each application for a "Livestock Special Sale" shall include:

1. Name and address of person requesting permit
2. Location of sale premises
3. Date and time of sale
4. Signature, complete address, and telephone number of person requesting the permit

##### **35:15-9-8 Written Records**

Each permit holder must keep the following written records or any other written records for not less than twenty-four (24) months which are necessary and adequate to determine the sources and disposition of livestock that are sold:

1. Accounts of sales
2. Accounts of purchases
3. Bills and invoices to buyers
4. documents certifying the health status of animals presented by consignors, and
5. All other written correspondence pertaining to livestock advertised or sold in the sale

##### **35:15-9-9 Submission of Record Sales**

The person responsible for a sale shall submit to the Board, within fifteen (15) days after the sale, a record identifying and showing the sex and breed of each animal consigned from out-of-state which was purchased by an Oklahoma buyer, along with the name and address of the consignor, and the name and address of the purchaser.

##### **35:15-0-10 Records Available for Inspection**

All records of "Livestock Special Sales" must be available for inspection by an authorized agent of the Board during normal working hours.
